Trading Update
Power Generation For December 2019**

This announcement is made by CGN New Energy Holdings Co., Ltd. (the “**Company**”) on a voluntary basis.

The board (the “**Board**”) of directors (the “**Directors**”) of the Company announces that, according to the preliminary statistics of the Company, the power generation of the Company and its subsidiaries (the “**Group**”) on a consolidated basis amounted to 1,168.7 GWh for the month of December 2019, representing an increase of 20.5% compared with the corresponding period of 2018. In particular, power generation of PRC wind projects increased by 40.9%, power generation of PRC solar projects increased by 16.9%, power generation of PRC coal-fired, cogen and gas-fired projects decreased by 38.7%, power generation of PRC hydro projects decreased by 27.1% and power generation of Korea gas-fired projects increased by 43.5%. For the twelve months ended 31 December 2019, the accumulated power generation of the Group amounted to 13,541.0 GWh, representing an increase of 1.8% compared with the corresponding period of 2018. In particular, power generation of PRC wind projects increased by 20.8%, power generation of PRC solar projects increased by 69.4%, power generation of PRC coal-fired, cogen and gas-fired projects decreased by 8.0%, power generation of PRC hydro projects increased by 10.1% and power generation of Korea gas-fired projects decreased by 7.4%.
