Trading Update
Power Generation For April 2020**

This announcement is made by CGN New Energy Holdings Co., Ltd. (the “**Company**”) on a voluntary basis.

The board (the “**Board**”) of directors (the “**Directors**”) of the Company announces that, according to the preliminary statistics of the Company, the power generation of the Company and its subsidiaries (the “**Group**”) on a consolidated basis amounted to 1,130.7 GWh for the month of April 2020, representing a decrease of 4.7% compared with the corresponding period of 2019. In particular, power generation of PRC wind projects increased by 47.0%, power generation of PRC solar projects increased by 66.1%, power generation of PRC coal-fired, cogen and gas-fired projects decreased by 78.0%, power generation of PRC hydro projects decreased by 4.8% and power generation of Korea gas-fired projects decreased by 21.9%. For the four months ended 30 April 2020, the accumulated power generation of the Group amounted to 4,550.8 GWh, representing an increase of 1.4% compared with the corresponding period of 2019. In particular, power generation of PRC wind projects increased by 42.5%, power generation of PRC solar projects increased by 47.6%, power generation of PRC coal-fired, cogen and gas-fired projects decreased by 79.9%, power generation of PRC hydro projects decreased by 11.6% and power generation of Korea gas-fired projects decreased by 0.4%.

¹: Since January 2020, one of the projects has temporarily stopped operations due to, among others, its restricted access to local water supply, which caused a year-on-year decrease in power generation in April 2020.

²: Due to the outbreak of the novel coronavirus (COVID-19), year-on-year power generation of Korea gas-fired projects decreased in April this year.
