Trading Update  
Power Generation For May 2020**

This announcement is made by CGN New Energy Holdings Co., Ltd. (the “**Company**”) on a voluntary basis.

The board (the “**Board**”) of directors (the “**Directors**”) of the Company announces that, according to the preliminary statistics of the Company, the power generation of the Company and its subsidiaries (the “**Group**”) on a consolidated basis amounted to 1,188.6 GWh for the month of May 2020, representing an increase of 3.1% compared with the corresponding period of 2019. In particular, power generation of PRC wind projects increased by 46.6%, power generation of PRC solar projects increased by 61.3%, power generation of PRC coal-fired, cogen and gas-fired projects decreased by 72.7%, power generation of PRC hydro projects decreased by 19.1% and power generation of Korea gas-fired projects decreased by 14.0%. For the five months ended 31 May 2020, the accumulated power generation of the Group amounted to 5,739.4 GWh, representing an increase of 1.7% compared with the corresponding period of 2019. In particular, power generation of PRC wind projects increased by 43.6%, power generation of PRC solar projects increased by 50.7%, power generation of PRC coal-fired, cogen and gas-fired projects decreased by 78.7%, power generation of PRC hydro projects decreased by 13.6% and power generation of Korea gas-fired projects decreased by 2.8%.

<sup>1</sup>: Since January 2020, one of the projects has temporarily stopped operations due to, among others, its restricted access to local water supply, which caused a year-on-year decrease in power generation in May 2020.

<sup>2</sup>: As a result of the reduction of incoming water flow, year-on-year power generation decreased in May 2020.

<sup>3</sup>: Due to the outbreak of the novel coronavirus (COVID-19), year-on-year power generation of Korea gas-fired projects decreased in May this year.
