Trading Update
Power Generation For June 2024**

This announcement is made by CGN New Energy Holdings Co., Ltd. (the “**Company**”) on a voluntary basis.

The board (the “**Board**”) of directors (the “**Directors**”) of the Company announces that, according to the preliminary statistics of the Company, the power generation of the Company and its subsidiaries (the “**Group**”) on a consolidated basis amounted to 1,422.4GWh for the month of June 2024, representing a decrease of 9.6% compared with the corresponding period of 2023. In particular, power generation of PRC wind projects decreased by 4.1%, power generation of PRC solar projects increased by 18.0%, power generation of PRC cogen and gas-fired projects increased by 30.6%, power generation of PRC hydro projects increased by 54.4% and power generation of Korea projects decreased by 28.0%. For the six months ended 30 June 2024, the accumulated power generation of the Group amounted to 9,660.4GWh, representing a decrease of 4.7% compared with the corresponding period of 2023. In particular, power generation of PRC wind projects decreased by 5.6%, power generation of PRC solar projects increased by 22.1%, power generation of PRC cogen and gas-fired projects increased by 17.4%, power generation of PRC hydro projects increased by 24.5% and power generation of Korea projects decreased by 11.8%.

¹: The capacity of the Company's solar projects increased significantly year-on-year in June 2024, resulting in a year-on-year increase in power generation in June 2024.

²: A cogen project located in Jiangsu Province increased its dispatch capacity in June 2024 compared to the same period last year, resulting in a year-on-year increase in power generation in June 2024.

³: The hydro projects located in Guangxi Zhuang Autonomous Region and Sichuan Province experienced a significant increase in water inflows in June 2024 compared to the same period last year, resulting in a year-on-year increase in power generation in June 2024.

⁴: In June 2024, the Yulchon II Gas-fired project in Korea entered an overhaul period. In addition, the Yulchon I Gas-fired project in Korea experienced a year-on-year decrease in the load of power grid dispatch in June 2024, resulting in a year-on-year decrease in power generation in June 2024.

Note: Certain figures included in this announcement have been subject to rounding adjustments, or have been rounded to one decimal place. Any discrepancies between the total shown and the sum of the amounts listed are due to rounding.
