Announcement Trading Update Power Generation For January 2025

This announcement is made by CGN New Energy Holdings Co., Ltd. (the "Company") on a voluntary basis.

The board (the "Board") of directors (the "Directors") of the Company announces that, according to the preliminary statistics of the Company, the power generation of the Company and its subsidiaries (the "Group") on a consolidated basis amounted to 1,527.6GWh for the month of January 2025, representing a decrease of 7.5% compared with the corresponding period of 2024. In particular, power generation of PRC wind projects increased by 9.4%, power generation of PRC solar projects increased by 18.2%, power generation of PRC cogen and gas-fired projects decreased by 5.1%, power generation of PRC hydro projects decreased by 3.3% and power generation of Korea projects decreased by 34.0%.

Details of the power generation of the Group for January 2025 (with corresponding period of 2024) are set out as follows:

- The dispatch capacity of a gas-fired project located in Hubei Province, the PRC decreased in January 2025 compared to the same period last year, resulting in a year-on-year decrease in power generation in January 2025.
- The hydro project located in Guangxi Zhuang Autonomous Region, the PRC decreased in water inflows in January 2025 compared to the same period last year, resulting in a year-on-year decrease in power generation in January 2025.
- The Company's Yulchon gas-fired project in Korea experienced a significant year-on-year decrease in dispatch load in January 2025, resulting in a year-on-year decrease in power generation in January 2025.
