## Announcement Trading Update Power Generation For October 2019

This announcement is made by CGN New Energy Holdings Co., Ltd. (the "**Company**") on a voluntary basis.

The board (the "Board") of directors (the "Directors") of the Company announces that, according to the preliminary statistics of the Company, the power generation of the Company and its subsidiaries (the "Group") on a consolidated basis amounted to 1,094.5 GWh for the month of October 2019, representing a decrease of 16.9% compared with the corresponding period of 2018. In particular, power generation of PRC wind projects increased by 21.1%, power generation of PRC solar projects increased by 21.3%, power generation of PRC coal-fired, cogen and gas-fired projects decreased by 14.1%, power generation of PRC hydro projects decreased by 13.4% and power generation of Korea gas-fired projects decreased by 30.1%. For the ten months ended 31 October 2019, the accumulated power generation of the Group amounted to 11,230.3 GWh, representing a decrease of 1.2% compared with the corresponding period of 2018. In particular, power generation of PRC wind projects increased by 15.7%, power generation of PRC solar projects increased by 81.4%, power generation of PRC coal-fired, cogen and gas-fired projects decreased by 3.9%, power generation of PRC hydro projects increased by 15.6% and power generation of Korea gas-fired projects decreased by 12.9%.
